TRANSFER PROVISIONS

Students must complete 120 credits to obtain a Bachelor's degree. A maximum of 90 combined nontraditional and transfer credits may be accepted and applied toward the 120 credit requirement. Within the 90 credit maximum, a maximum of 75 nontraditional credits may be applied toward degree completion. Official transfer credit evaluation takes place once a student is enrolled at Ashford University, and all official transcripts have been received.
