Grant Awards

Online Non-Term Programs: Applicants awarded this Grant will be eligible for a waiver of the Technology Services Fee and net tuition costs for every third course, after the successful completion of preceding courses. Dissertation courses are not covered.

Online Master of Arts in Counseling Program: Applicants awarded this Grant will be eligible for a waiver of the Technology Fee and a 20% tuition grant for each course. Practicum and Internship courses are not covered.

Applicant Eligibility Requirements:

- Applicant must be enrolled in an online degree program at University of the Rockies;
- A non-U.S. resident and non-U.S. citizen;
- In good financial standing with the University; and
- Has submitted their official TOEFL (if applicable) and official evaluation from Educational Credentials Evaluators (ECE), World Education Services (WES), or another approved evaluator*.

*Official transcripts from a United States institution, with regional or approved national accreditation, granting a post-secondary degree may be submitted instead.

All required documentation must be on file with the University for the Grant to be awarded. In addition, computers, books, supply costs, dissertation tuition and fees, and any additional fees will continue to be the sole responsibility of the grant recipient (unless these costs are covered independently by another grant or scholarship).

Each Grant takes the form of a non-cash credit to University of the Rockies, and no check or cash payments will be given and/or refunded from any Grant award at any time. No exceptions. For students that participate in other institutional-funded grant or grant programs, this Grant will be awarded up to the net of the affected charged for the applicable course. If the student drops after posting attendance in the third course (non-term) or in any course (MA Counseling) the Grant will be adjusted to the net amount of tuition charged to the student account in accordance with the University's tuition refund policy.

In order to maintain eligibility, grant recipients must remain continuously enrolled at the University. Grant awards will not be allocated towards a repeat course. The Grant will not be applied retroactively if the grant recipient has already started or completed their third course (non-term) or first term (MA Counseling).
